



GENERAL WARRANTY CONDITIONS KRONE TRAILER AXLE

Version November 2019

I. Scope of warranty

KRONE provides a warranty for product defects which can be proven to have occurred during the warranty period and can be proven to be due to a material or manufacturing defect. Apart from the seller's statutory liability for material defects, the warranty also includes the purchase agreement with the initial customer and does not affect the purchaser's statutory rights.

The warranty period depends on the use of the vehicle, which is defined in Section 3. The warranty covers the cost of replacement of damaged components as well as the labour costs within the scope of the conditions stipulated by KRONE. The warranty is only applicable for damage to KRONE products and no other manufacturer. Consequential damage - in particular towing charges, rental costs of replacement vehicles, claims for lost profit or claims for damage - are excluded from the warranty. Any further liability based on mandatory, statutory provisions remains unaffected by this.

II. Limitations of liability

The warranty does not cover damage to wear components (e.g. brake pads, brake discs) and damage caused by inappropriate use of the KRONE axle systems, lack of brake power train alignment, mechanical damage caused by an accident, fall, impact, negligent or intentional destruction, as well as fire and misuse of the vehicle (for example: overloading, overheating, use under abnormal conditions), incorrect maintenance, in particular omitting the regular test and maintenance work described in the KRONE test and maintenance guidelines (for the latest version see www.krone-trailer.com), conversion of parts or modifications of the KRONE axle systems, or the use of parts originating from third parties instead of original KRONE spare parts, or by using unsuitable lubricants and liquids.

The warranty also does not cover phenomena such as noises, smells, vibrations or oil leaks which have no impact on the serviceability of the KRONE axle systems. If the defect appears within 6 months of initial delivery of the vehicle to the original purchaser from KRONE, then it is refutably assumed that it is a material or manufacturing defect.

III. Warranty period

The warranty starts on the date the vehicle is delivered to the original purchaser from KRONE. The warranty period depends on the use and the geographical deployment area of the vehicle:

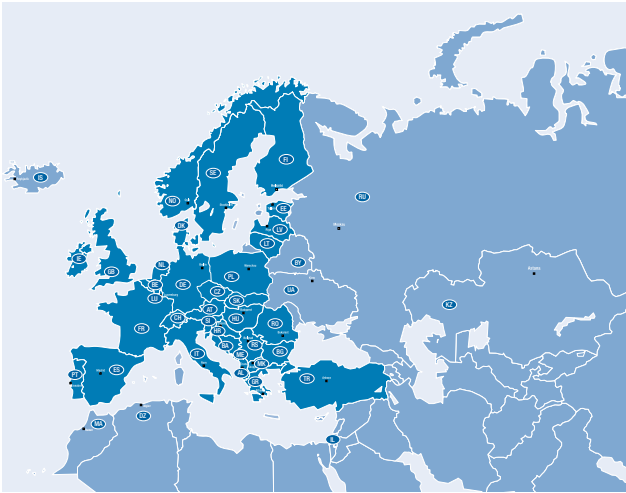
Definition of use:

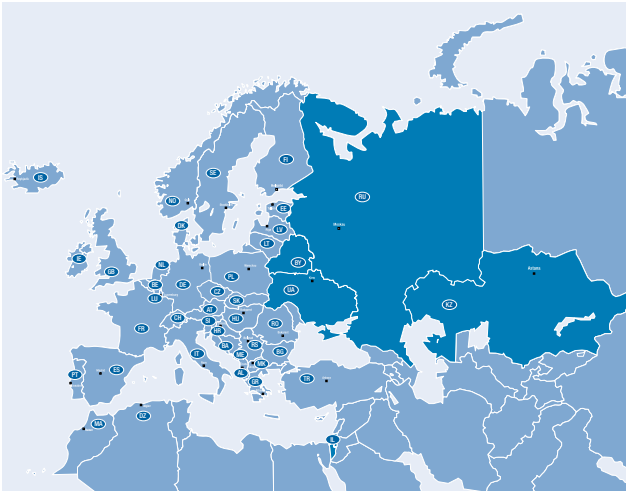

National restrictions and warranty periods as above; however, max. 3 years construction and manufacturing warranty excluding natural wear as justification of a claim.

General conditions

For the warranty to be valid, it is crucial that the maintenance and service intervals for the respective axle have been meticulously adhered to and documented.

To determine the exact mileage, the displays for ABS, EBS, and similar measuring systems apply; provided that it is possible to fully ascertain the total mileage of the vehicle in this manner. Providing incorrect mileage or manipulating measuring instruments will invalidate the warranty.

The warranty is not extended as a result of making a claim. For parts replaced under warranty, the warranty period is 6 months minimum, regardless of the current warranty period.

IV. Making a warranty claim

A warranty claim is made by sending a KRONE warranty application to KRONE. The KRONE warranty application must include the information it requests. The KRONE warranty application can be downloaded from www.krone-trailer.com.

The following must be included with the KRONE warranty application:

- a copy of the servicing history
- the digital EBS/ODR data sets for claims being made concerning the wheel hub units
- the log of the brake power train alignment and the digital EBS/ODR data sets for claims regarding the brake components

A warranty claim must be submitted to KRONE at the latest within 2 weeks of finding the defect. The faulty components which have been removed must be kept and must not be disposed of until permission has been given by KRONE. Costs incurred due to unjustified warranty claims may be invoiced by KRONE.
